## **NOTIFICATION**

Telangana Admission and Fee Regulatory Committee (TAFRC) proposes to reviewand determine fee structures for the programmes, viz., B.E/B.TECH, M.E/M.TECH, B.ARCH, M.ARCH, B.PLANNING, M.PLANNING, B-PHARMACY, M-PHARMACY, PHARMA-D & PHARMA-D(PB), MBA & MCA, LLB/B.L,LLM/ M.L, B.Ed, and M.Ed D.P.Ed, U.G.D.P.Ed and other Courses if any that are covered under the Jurisdiction of TAFRC for fee fixation in Private Un-aided Professional Institutions in the State of Telangana for the Block Period 2025-26 to 2027-28.

The Managements of the concerned Private Un-aided Professional Colleges in the State of Telangana are hereby required to submit relevant data relating to the year 2021 -2022, together with their Audited Financial Statements for the years 2023-2024, on-line at <a href="https://tafrconline.telangana.gov.in/">https://tafrconline.telangana.gov.in/</a> by 30.10.2024 along with Hard Copy, positively (last date for submission of the relevant data along with the fee proposals), as per the guide-lines available in the same web site. On line submission can be made from 20.08.2024 onwards. The data shall be furnished programmewise, paying the prescribed processing charges as prescribed in the Guidelines link available at <a href="https://tafrconline.telangana.gov.in/">https://tafrconline.telangana.gov.in/</a>, through online payment gateway.

As per the directions of Hon'ble High court of A.P., WP's No.16547/2010 and batch reported in 2012(3) ALT 686 (D.B.) is "....an institution which is unresponsive or does not submit statements of income and expenditure, audited balance sheetsas may be specified (with supporting bills, vouchers or receipts, etc.,) shall not be permitted to collect any fee."

In case of failure to furnish specified data as mentioned above or submission of proposal with incomplete data the institution/college will not been titled for determination fee and will not be allowed to collect any fee from the students for the block period 2025-26 to 2027-28 in terms of the said judgment.
