Vide this office Notice dated 24.10.2024, the last date for submitting online applications for fixation of tuition fee structure for the block period 2025-2028 was earlier set as 18th November 2024, with the last date for submitting hardcopies as 23th November 2024.

Considering the ongoing TGPSC - Group II and III Exams scheduled on 18th November, 2024 and the circular issued by JNTUH on 09.11.2024 regarding faculty selection interviews for Assistant Professors, scheduled from 21st to 27th November 2024. **It is felt necessary to extend the Deadline for submitting online proposals and hardcopies. Therefore, the last date is now extended till 30th November 2024 for submitting online applications and last date for submitting hardcopies is extended till 9th December 2024.**

To discourage the institutions from requesting further time, it is ordered that the institutions which are failed to submit applications through online by 30th November 2024 can submit their applications online till 8th December 2024 but on payment of penalty as detailed below and the last date for submitting hardcopies by 16th December, 2024.
